AN ACT

- 1 Amending the act of June 13, 1967 (P.L.31, No.21), entitled "An
- act to consolidate, editorially revise, and codify the public
- welfare laws of the Commonwealth," changing the name of the
- 4 Department of Public Welfare to the Department of Human
- 5 Services; and providing for a transition period.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 102 of the act of June 13, 1967 (P.L.31,
- 9 No.21), known as the Public Welfare Code, is amended to read:
- 10 Section 102. Definitions. -- Subject to additional definitions
- 11 contained in subsequent articles of this act, the following
- 12 words when used in this act shall have, unless the context
- 13 clearly indicates otherwise, the meanings given them in this
- 14 section:
- "Department" means the Department of [Public Welfare] Human
- 16 Services of this Commonwealth.
- "Secretary" means the Secretary of [Public Welfare] Human
- 18 <u>Services</u> of this Commonwealth.

- 1 Section 2. The act is amended by adding a section to read:
- 2 Section 103. Redesignation. -- (a) The Department of Public
- 3 Welfare shall be known as the Department of Human Services.
- 4 (b) A reference to the Department of Public Welfare in a
- 5 statute or a regulation shall be deemed a reference to the
- 6 <u>Department of Human Services.</u>
- 7 (c) In order to provide an efficient and cost-minimizing
- 8 transition, licenses, contracts, deeds and any other official
- 9 <u>actions of the Department of Public Welfare shall not be</u>
- 10 affected by the use of the designation of the department as the
- 11 Department of Human Services. The department may continue to use
- 12 the name Department of Public Welfare on badges, licenses,
- 13 contracts, deeds, stationery and any other official documents
- 14 <u>until existing supplies are exhausted. The Department of Public</u>
- 15 Welfare may substitute the title "Department of Human Services"
- 16 for "Department of Public Welfare" on its documents and
- 17 materials on such schedule as it deems appropriate.
- 18 (d) The Department of Human Services shall not replace
- 19 existing signage at department locations with the redesignated
- 20 name until the signs are worn and in need of replacement. This
- 21 transition shall be coordinated with changes in administration.
- 22 (e) The department shall continue to use the name Department
- 23 of Public Welfare on its computer systems until the time of
- 24 routine upgrades in each computer system in the department. The
- 25 change in name shall be made at the time of the routine upgrade
- 26 to the department computer systems.
- 27 Section 3. This act shall take effect immediately.
