1 2 3 4 5 6 7 8 9 10 11 12 13 14 15 16 17 18 19 20 21 22	Amending the act of April 9, 1929 (P.L.177, No.175), entitled "An act providing for and reorganizing the conduct of the executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative departments, boards, and commissions; defining the powers and duties of the Governor and other executive and administrative officers, and of the several administrative departments, boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, and commissions; and prescribing the manner in which the number and compensation of the deputies and all other assistants and employes of certain departments, boards and commissions shall be determined," further providing for powers and duties of the Department of Drug and Alcohol Programs.
23	The General Assembly of the Commonwealth of Pennsylvania
24	hereby enacts as follows:
25	Section 1. Section 2301 A(9) of the act of April 9, 1929 <
26	(P.L.177, No.175), known as The Administrative Code of 1929,

1	added June 9, 2010 (P.L.348, No.50), is amended and the section
2	is amended by adding a paragraph to read:
3	Section 2301-A. Powers and duties.
4	The Department of Drug and Alcohol Programs shall have the
5	power and its duty shall be:
6	<u>* * *</u>
7	(9) [The department shall have the power to] <u>To</u>
8	promulgate the rules and regulations necessary to carry out
9	the provisions of this article.
10	(10) To promulgate regulations regarding housing
11	programs that offer assistance to people with drug or alcohol
12	abuse problems, sometimes referred to as recovery houses. The
13	regulations shall include, but not be limited to, a
14	definition of "recovery house," rights of inspection,
15	assignment of rights of inspection and penalties when
16	violations of a departmental regulation occur. In order to
17	receive any Federal or State funding, a recovery house must
18	comply with regulations promulgated by the Department of Drug
19	and Alcohol Programs.
20	Section 2. The regulations promulgated initially under-
21	section 2301-A of the act of April 9, 1929 (P.L.177, No.175),
22	known as The Administrative Code of 1929, shall be developed
23	with the assistance and recommendations of a task force
24	consisting of the chairperson and minority chairperson of the
25	Public Health and Welfare Committee of the Senate, the-
26	chairperson and minority chairperson of the Human Services
27	Committee of the House of Representatives, the prime sponsor of
28	paragraph (10) of section 2301 A of the act and a representative-
29	of the Drug and Alcohol Services Providers of Pennsylvania.
30	Section 3. This act shall take effect in 30 days.

1	SECTION 1. THE ACT OF APRIL 9, 1929 (P.L.177, NO.175), KNOWN <
2	AS THE ADMINISTRATIVE CODE OF 1929, IS AMENDED BY ADDING
3	SECTIONS TO READ:
4	SECTION 2302-A. DEFINITIONS.
5	THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ARTICLE
6	SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
7	CONTEXT CLEARLY INDICATES OTHERWISE:
8	"DEPARTMENT." THE DEPARTMENT OF DRUG AND ALCOHOL PROGRAMS OF
9	THE COMMONWEALTH.
10	"DRUG AND ALCOHOL RECOVERY HOUSE." A SAFE AND SUPPORTIVE,
11	ALCOHOL AND DRUG-FREE ENVIRONMENT WHERE RESIDENTS IN RECOVERY
12	FROM ALCOHOL OR OTHER DRUG ADDICTION LIVE TOGETHER AS A
13	COMMUNITY.
14	SECTION 2303-A. DEVELOPMENT OF CRITERIA.
15	THE DEPARTMENT SHALL DEVELOP CRITERIA FOR CERTIFICATION OF
16	DRUG AND ALCOHOL RECOVERY HOUSES THAT RECEIVE FUNDS FROM THE
17	DEPARTMENT TO ENSURE THAT THE HOUSES PROVIDE A SAFE ENVIRONMENT
18	FOR RESIDENTS AND FOR THE SURROUNDING COMMUNITY.
19	SECTION 2304-A. FUNDING.
20	A DRUG AND ALCOHOL OR OTHER RECOVERY HOUSE SHALL NOT RECEIVE
21	FUNDING FROM THE DEPARTMENT WITHOUT CERTIFICATION.
22	SECTION 2305-A. CERTIFICATION REQUIREMENTS.
23	CERTIFICATION REQUIREMENTS SHALL INCLUDE, BUT NOT BE LIMITED
24	TO, THE FOLLOWING:
25	(1) PROCEDURES REQUIRING COMPLIANCE WITH ALL STATE AND
26	LOCAL ORDINANCES.
27	(2) PROCEDURES ADDRESSING THE SAFETY AND PROTECTION OF
28	RESIDENTS AND THE COMMUNITY.
29	(3) POLICIES WHICH PROMOTE RECOVERY BY REQUIRING
30	RESIDENT PARTICIPATION IN TREATMENT, SELF-HELP GROUPS OR

- 15 SECTION 2. THIS ACT SHALL TAKE EFFECT IN 90 DAYS.
