- 2 This chapter shall be known and may be cited as the Emergency
- 3 Addiction Treatment Act.
- 4 § 8302. Definitions.
- 5 The following words and phrases when used in this chapter
- 6 shall have the meanings given to them in this section unless the
- 7 <u>context clearly indicates otherwise:</u>
- 8 "Department." The Department of Drug and Alcohol Programs of
- 9 <u>the Commonwealth.</u>
- 10 "Program." The Emergency Addiction Treatment Program
- 11 established in section 8310 (relating to Emergency Addiction
- 12 <u>Treatment Program</u>).

- 18 (a) Establishment. -- The Emergency Addiction Treatment
- 19 Program is established in the Department of Drug and Alcohol
- 20 Programs to provide addiction treatment in licensed long-term
- 21 residential addiction treatment facilities, including licensed
- 22 halfway houses, for individuals who are unable to obtain timely
- 23 or appropriate treatment, as determined by the department, and
- 24 to establish such treatment facilities. The program shall be
- 25 administered by the department.
- 26 (b) Powers and duties of department. -- In order to provide
- 27 individuals seeking assistance with better and more timely
- 28 access to drug and alcohol addiction treatment, the department
- 29 shall:
- 30 (1) Maintain a toll-free telephone number to assist

- individuals seeking help for drug and alcohol problems. The
- 2 <u>telephone number shall be posted on the department's publicly</u>
- 3 accessible Internet website and shall be posted or published
- 4 <u>by the department in such other media as the department</u>
- 5 <u>determines is necessary to reach as many individuals as</u>
- 6 <u>possible.</u>
- 7 (2) Provide assistance in accessing addiction treatment.
- 8 The department may provide this service by contract.
- 9 <u>(3) Develop and maintain a database identifying problems</u>
- 10 <u>and patterns in accessing appropriate addiction treatment.</u>
- 11 (4) Develop and provide a program to educate and counsel
- 12 <u>families with addiction problems on how to prevent and treat</u>
- 13 <u>addiction</u>.
- 14 (5) Prepare an annual report to the General Assembly on
- the activities described in paragraphs (1), (2) and (3),
- 16 <u>including recommendations for improving access to addiction</u>
- 17 treatment. The report shall be posted on the department's
- publicly accessible Internet website.
- 19 (c) Guidelines. The department shall develop and forward to <--
- 20 the Legislative Reference Bureau for publication in the
- 21 Pennsylvania Bulletin guidelines for the implementation of the
- 22 program established under section 1203 B of the act of March 4,
- 23 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, and to
- 24 govern the eligible use of the fund by counties and other
- 25 entities or persons that provide addiction treatment services to
- 26 individuals in licensed long term residential addiction
- 27 treatment facilities, including halfway houses.
- 28 Section 2. This act shall take effect in 60 days.
